Use the Arizona Tax Credit for contributions to qualifying charitable organizations.

(You will need to supply this number when filing your AZ taxes)

state or increase the amount of the taxpayer's refund, dollar-for-dollar. There is NO NET COST to the donor.

AZ Department of Revenue: "Effective in 2016, credit eligible contributions made on or before the 15th day of the fourth month following the close of the taxable year may be applied to either the current or the preceding taxable year and are considered to have been made on the last day of that taxable year."

- ✓ Couples who file jointly can reduce their state taxes by up to \$1009. Individuals or head of household filers can claim a tax credit of up to \$506.
- ✓ You make the donation to the center before April 15, 2027 and the tax credit is claimed on Arizona Tax Form 321, which you file with your tax return.
- ✓ You don't have to itemize deductions to claim the credit.

You may have heard of the Arizona Charitable Tax Credit, but may not know the details and how to take advantage of them! That's okay and we hope the information below helps!

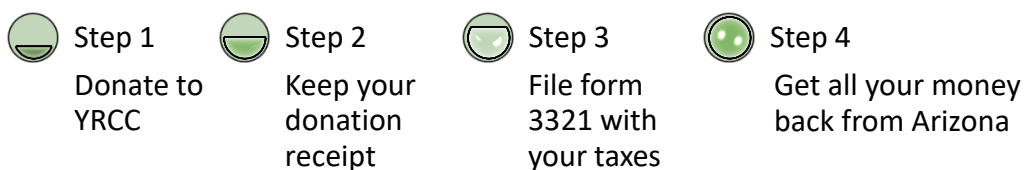
These tax credits allow taxpayers to make charitable contributions and receive dollar-for-dollar reductions in their Arizona State tax liabilities, in essence, the Arizona Charitable Tax Credit empowers you to decide on how your tax dollars are used.

By donating to an eligible charitable organization of your choice, you have the opportunity to support a cause you deeply care about and make a positive impact in your local community. What makes the AZ Charitable Tax Credit truly remarkable is that you can channel your tax dollars to the charities you believe in, without incurring any actual cost to yourself. When you make your donation to an eligible charity in your community, you can actually see your donations at work. You can help your senior neighbors who are facing hunger, loneliness, and the ability to stay in their homes – all through the AZ Charitable Tax Credit by giving to Meals on Wheels through the Yarnell Regional Community Center.

You can take advantage of this credit to help those most in need in our community, and it won't cost you a penny. How to use the Arizona Charitable Tax Credit can be very simple if you make use of this tax.



The maximum allowable credit for contributions to QCOs for single taxpayers, married filing separately, or heads of households for the 2026 tax year is \$506.00. The maximum allowable credit for contributions to QCOs for joint taxpayers, for 2026 tax year, is \$1009.00. Please consult with a tax adviser.
